Speaker Presentation:

Texas Justice Court Training Center is the go to resource for Texas attorneys and judges. You can visit their website, https://www.tjctc.org/, and look for the Deskbooks under the Legal Resource tab for a copy of Evictions Deskbook, which covers procedures in eviction cases and other landlord/tenant issues.

Evictions Must Haves - Notice to Vacate

Proof of Landlord/Tenant Relationship

Reason for Eviction filing. - One of the biggest misconceptions is you can not take payment once eviction has filed. You are allowed to take payment because you are evicting on lease violation.

Eviction Proceedings - Some judges will let you amend the eviction filing in court. Late fees are not awarded. You can only sue for back rents. Landlords have the option on how to apply payments received from Tenants. For example, if the Tenant owes \$500 in late fees and \$500 in back rents, the landlord may apply payment to the late fees first. It is suggested that you put into plain writing your payment application order. Court costs, certified mail fees, and other charges are separate from backrents and can not be added to eviction filing. When evicting on Section 8 or housing vouchers, the Notice to Vacate can still be posted with a 3-day notice if the Tenant is paying a portion of the rent. If an outside entity like Section 8 is paying the entire rent balance, you must post a 30-day notice.

Security Deposits - You have 30 days to get the itemized list out. You are permitted to deduct damages only, not improvements or normal wear and tear. If you do not receive a written notice of the Tenant's forwarding address, still process the security deposit within 30–days and mail to the property address they just vacated or email it. Do not wait on the written notice of the forwarding address and do your part to prove you attempted to itemize the deposit because it is not worth owing 3 times that deposit amount.

Notice to Vacate - must be posted on the inside of the mail entry door. If you can not access the inside of the main entry door, you can post it on the outside but it must be in an envelope that says IMPORTANT DOCUMENTS and contained in a weather proof protectant. Do reference the Evictions Deskbook for specifics. Even if you post the Notice to Vacate, still mail the notice. You are not required to mail it certified, although certified offers the most protection and

proof. Make sure to file eviction after the 3 days prescribed in Notice posted and/or mailed.

Nonpayment due to Repairs - Repairs are considered in eviction cases. Tenants are not allowed to withhold rent but also not use the money for repairs. If the Tenant withholds the rent and does repair, they must provide receipts. If the landlord has addressed the repair, that is also taken into consideration.

Other - All COVID moratoriums have been lifted. Some judges can be pro-Tenant. Make sure to do your research. Consider finding agencies that will offer rent assistance should a Tenant ever get in a bind. You can direct Tenants to such agencies to prove you did your part to help the Tenant and help your case. If a judge is wrong in their rulings, you have the right to go to the appeal process and as a last resort you can file a complaint against them. Commercial is different from residential. Do not change the locks on a residential property, it is very complicated and not worth it. Changing the locks on commercial is a bit less complicated. Writ of Possession can be done 6 days post eviction ruling. Not too many eviction cases are being appealed right now from his experience. You can postpone up to one week, any postponement beyond one week will have to be done by amendment.

Truckmount - They offer a variety of carpet services including pet treatments, carpet stretching, and power bars. They can do almost anything except carpet replacement. They also offer water extractions, water damage inspections, tile and grout cleaning.

Speaker Presentation: Panel Consisted of Cortney Gill, Brian Phelt, and Katie Griffin Ross

Cortney Gill- brokerage does property management, real estate, staging. Property Management company manages 265 doors and has two virtual assistants that work approximately 40 hours per week at a rate of \$1,500 per month each. VA's are used for a variety of tasks that include bookkeeping, journal entries, social media. VA's are cross trained between all companies. Gill found her VA's through Summier VA. Summit has VA's that are already trained in property management. Gill has found her VA's to be very motivated and more willing to work.

Brian Phelt - manages about 201 doors and found his VA through VPM Solutions. Cost is approximately \$2,000 per month for a 40 hour week. Phelt's VAs do everything for his property management company except accounting. He uses Slack to communicate with them.

Katie Griffin Ross - real estate office only. Also found her VA through Summer VA. Cost is approximately \$1,500 per month for one VA. She uses her VA for marketing, a transaction coordinator, client gift ordering, all paperwork. Ross set up email templates for her VA to use and most of her clients don't realize the VA is not in the office.

Speaker Presentation:

Texas Justice Court Training Center is the go to resource for Texas attorneys and judges. You can visit their website, https://www.tjctc.org/, and look for the Deskbooks under the Legal Resource tab for a copy of Evictions Deskbook, which covers procedures in eviction cases and other landlord/tenant issues.

Evictions Must Haves - Notice to Vacate

Proof of Landlord/Tenant Relationship

Reason for Eviction filing. - One of the biggest misconceptions is you can not take payment once eviction has filed. You are allowed to take payment because you are evicting on lease violation.

Eviction Proceedings - Some judges will let you amend the eviction filing in court. Late fees are not awarded. You can only sue for back rents. Landlords have the option on how to apply payments received from Tenants. For example, if the Tenant owes \$500 in late fees and \$500 in back rents, the landlord may apply payment to the late fees first. It is suggested that you put into plain writing your payment application order. Court costs, certified mail fees, and other charges are separate from backrents and can not be added to eviction filing. When evicting on Section 8 or housing vouchers, the Notice to Vacate can still be posted with a 3-day notice if the Tenant is paying a portion of the rent. If an outside entity like Section 8 is paying the entire rent balance, you must post a 30-day notice.

Security Deposits - You have 30 days to get the itemized list out. You are permitted to deduct damages only, not improvements or normal wear and tear. If you do not receive a written notice of the Tenant's forwarding address, still process the security deposit within 30–days and mail to the property address they just vacated or email it. Do not wait on the written notice of the forwarding address and do your part to prove you attempted to itemize the deposit because it is not worth owing 3 times that deposit amount.

Notice to Vacate - must be posted on the inside of the mail entry door. If you can not access the inside of the main entry door, you can post it on the outside but it must be in an envelope that says IMPORTANT DOCUMENTS and contained in a weather proof protectant. Do reference the Evictions Deskbook for specifics. Even if you post the Notice to Vacate, still mail the notice. You are not required to mail it certified, although certified offers the most protection and

proof. Make sure to file eviction after the 3 days prescribed in Notice posted and/or mailed.

Nonpayment due to Repairs - Repairs are considered in eviction cases. Tenants are not allowed to withhold rent but also not use the money for repairs. If the Tenant withholds the rent and does repair, they must provide receipts. If the landlord has addressed the repair, that is also taken into consideration.

Other - All COVID moratoriums have been lifted. Some judges can be pro-Tenant. Make sure to do your research. Consider finding agencies that will offer rent assistance should a Tenant ever get in a bind. You can direct Tenants to such agencies to prove you did your part to help the Tenant and help your case. If a judge is wrong in their rulings, you have the right to go to the appeal process and as a last resort you can file a complaint against them. Commercial is different from residential. Do not change the locks on a residential property, it is very complicated and not worth it. Changing the locks on commercial is a bit less complicated. Writ of Possession can be done 6 days post eviction ruling. Not too many eviction cases are being appealed right now from his experience. You can postpone up to one week, any postponement beyond one week will have to be done by amendment.
